Dear Cerbat Water Company Customer,

On July 26, 2022 the Arizona Corporation Commission (“Commission”) approved a rate increase requested by Cerbat Water Company (“Company”). Per Decision 78631, the new rates become effective for all service provided on and after August 1, 2022.

The adopted rates will increase the typical residential bill for a 3/4-inch meter, with a median usage of 4,668 gallons, from \$53.61 to \$53.72, for an increase of \$0.11 or .21%.

Decision 78631 also authorizes the Company to obtain a 12-year amortizing loan from the Water Infrastructure Finance Authority of Arizona to finance meter replacements, in an amount not to exceed \$145,557 at an interest rate to be determined at the time the loan is closed. The Company anticipates the loan will close in January 2023 and the WIFA loan surcharge will take effect four months thereafter. With the estimated WIFA loan surcharge of \$6.78, the typical residential bill for a 3/4-inch meter, with a median usage of 4,668 gallons, would increase to \$60.50, a total increase from current rates of \$6.89 or 12.85%.
